

# UKWA NATIONAL SLALOM SERIES NOTICE OF RACE 2022



Version 1: 1st July 2022

The Organising Authority is the United Kingdom Windsurfing Association (UKWA)

### 1 RULES

- 1.1 The events and the series will be governed by the *rules* as defined in *The Racing Rules of Sailing 2021-2024*. These include Appendix B (windsurfing fleet racing rules), Appendix WF Wing foiling Racing Rules, the Prescriptions of the RYA, this Notice of Race, the Sailing Instructions, and the rules of the relevant International classes as amended by national class rules where applicable.
- 1.2 Club, council rules and byelaws apply if displayed on the premises of the club or council hosting the event.
- 1.3 Competitors should note that the UKWA implements the RYA Racing Charter and that they will be expected to sail in compliance with it. The Charter can be found at the front of the RYA edition of the Racing Rules of Sailing 2021-2024 (the yellow pages after the definitions), or on the RYA website at www.rya.org.uk/racingrules
- 1.4 The Exoneration Penalty, Advisory Hearing and RYA Arbitration of the RYA Rules Disputes Procedures will be available.
- 1.5 Covid-19 Competitors shall comply with UKWA Covid policies/rules and those of any host venue at all times. Failure to comply may lead to exclusion from the said event.

#### 2 ADVERTISING

- **2.1** Advertising will be allowed in accordance with the class rules of the competing classes. If no limitations are prescribed within the class rules, WS Regulation 20- Advertising Code shall take precedence.
- **2.2** Boards may be required to display advertising chosen and supplied by the Organising Authority.

### 3 ELIGIBILITY AND ENTRY

- **3.1** Racing will be for men and women in the following championship fleets:
  - Pro (Fin and Foil)
  - Amateur (Fin only)
  - Master Blaster (fin only)
  - Wingfoil
- 3.1.1 The race committee may if conditions and circumstances permit run light wind foil racing for the same fleets in 7 to 11 knots for any sailors who have entered and paid entry fees for the said event (excluding master blaster). There is no additional charge. Competitors may not switch between fleets.
- 3.1.2 Light wind foil Racing will be for men and women who entered in the following championship fleets:
  - Pro
  - Amateur
- **3.1.3** Competitors shall confirm their intention to enter for light wind foil racing at registration. Fleets may be raced together or separately depending on number of entries. Please refer to heat order board lightwind foiling posted on ONB.
- **3.1.4** Prizes will be at the sponsors discretion. Any results will be scored separately from the event scores and will be collated into a series score. Normal scoring rules apply.

### Within these fleets the following age categories (divisions) may be recognised:

- Junior (aged 16 or under as at 31st December 2022) max 9sq.m
- Youth (aged 20 or under as at 31st December 2022) max 10sq.m
- Master (40+ born 1981 or before)
- Grand Master (50+ born 1971 or before)
- Veteran (60+ born 1961 or before)
- **3.2** A sailor must be a member of the UKWA, or a non-UK resident who is a member of either their national windsurfing association or a World Sailing Member National Authority.
- **3.3** Temporary membership may be extended to all fleets once only and to Master Blaster competitors repeatedly. Weekend Wingfoil membership is included in the entry fee excluding third party insurance.
- **3.4** Entries should be made in advance through the UKWA website <a href="www.ukwindsurfing.com">www.ukwindsurfing.com</a>. except at the discretion of the Organising Authority. Online pre-entry closes at 10pm on the Monday prior to each event. Should you miss the deadline please contact <a href="mailto:admin@ukwindsurfing.com">admin@ukwindsurfing.com</a>
- **3.5** Before competing, each competitor shall register for the event at the Race Office and update or confirm an equipment registration form if required.
- 3.6 A competitor does not become eligible for series or event points by 'pre-entering', but only by registering at the event and being capable of sailing and intending to do so.
- 3.7 Parents of competitors under the age of 18 must agree a Parent / Guardian Declaration on line at time of entry.
- **3.8** Fleets may race together on a single start, depending on the number of entries. Individual classes within a fleet shall be raced and scored as a single fleet.
- **3.9** Boards must display sail numbers on both sides of the sail in accordance with RRS Appendix G and in accordance with B9. For the purpose of Appendix G, this is not an International event. Breaches of NOR 3.9 shall not be grounds for protest by

a boat. This changes RRS 60.1(a). Wingfoil competitors shall wear a numbered rash vest available from the race office (£10 cash deposit) – This changes WF 9.

- **3.10** Competitors must enter and race under their allocated number, other than with the express permission of the Race Committee. Excluding wingfoils see 3.9
- **3.11.1** Competitors shall make every effort to display their sail number. Sailors without a number displayed will be asked to fabricate a number on the day onto their sail. Excluding wingfoils see 3.9
- **3.11** A competitor not complying with 3.10 and 3.11.1 will be scored DSQ but may seek redress via a results query form and accept a 20% place penalty for each race whilst in breach of 3.10 and 3.11.1 without written permission of the Race Committee. This amends A5.
- 3.12 All sailors shall wear a sponsors rash vest when afloat. Excluding wingfoils
  - Pro fleet Yellow
  - Amateur fleet Blue
  - Masterblaster fleet Orange.

The rash vest shall be worn over any other clothing / wetsuit and remain visible at all times; however, they may be worn under any personal flotation device if preferred. Rash vests may be purchased from the race office.

#### 4 FEES

- **4.1** Entry fees are set out on the event website and UKWA website.
- **4.2** Before competing each competitor shall pay on line in advance any appropriate parking / camping charges or face rejection of their entry with no refund of entry fees. Whenever possible these charges will be announced in advance

### 5 SCHEDULE

- **5.1** Competitors shall register and confirm entry details at the Race Office on the first morning of racing from 08.00 09.30.
- 5.2 There will be a welcome and briefing for all competitors on the first morning of racing at 10:15, (in person or virtual)
- **5.3** Tally System: Tally numbers will be posted on the Official Notice Board, follow the link from the event page at <a href="https://www.ukwindsurfing.com">www.ukwindsurfing.com</a>
- **5.4** The scheduled time of the first warning signal is 10.55 and 09.55 on each subsequent day.
- **5.5** On the last day of the event no warning signal will be made after 16:00.
- **5.6** There will be no maximum number of races per day.
- **5.7 Minimum Conditions:** The intention is that all racing takes place in suitable conditions. The Race Officer shall be the sole judge of the suitability of conditions, and will take into account the effect of the speed and direction of any current, and wind measurements from as many parts of the course as possible.
- **5.7.1** The Race Officer may take into account the relevant Championship Rules of the International Funboard Class Association (IFCA).
- 5.7.2 Protests regarding wind strength and suitability of wind direction shall be disallowed

#### 6 SAILING INSTRUCTIONS

Sailing Instructions can be downloaded from the UKWA website (ukwindsurfing.com), and will be posted on the ONB.

### 8 COURSES

The course to the sailed will be detailed in the Sailing Instructions.

# 9 SERIES SCORING

- **9.1** A competitor does not become eligible for series or event points by 'pre-entering', but only by registering at the event and being capable of sailing and intending to do so.
- **9.2** The Low Point Scoring System of Appendix A will apply.
- 9.3 A minimum of 1 completed round is required for a valid Series event. A round is completed when a winners (gold) final is completed for that fleet. In the event of no loser's final (silver / bronze) being raced, each sailor in the losers final will be awarded last place in the winners final plus 2.
- **9.4** Each boards Series score will be the total of her finishing position in each valid event in the series as below. The competitor with the lowest score will win the title of National Champion in that fleet / division.
- **9.5** When fewer than 4 events have been completed, a boat's series score will be the total of all her race scores.
- 9.6 When from 4 to 5 events have been completed, a boat's series score will be the total of her race scores excluding her

worst score.

**9.7** When 6 to 7 events have been completed, a boat's series score will be the total of her race scores excluding her two worst scores.

#### 10 SAFETY REGULATIONS

- **10.1** All junior sailors who will be aged 17 or under on 31<sup>st</sup> December 2022 shall wear a personal flotation device appropriate to class rules at all times when afloat except briefly when changing or adjusting clothing or personal equipment. Excluding windfoils.
- **10.2** If the Y flag is flying, all competitors shall wear a personal flotation device appropriate to class rules at all times when afloat except briefly when changing or adjusting clothing or personal equipment. A personal flotation device may include an impact vest with a minimum of 50 Newtons
- **10.3** If conditions dictate, the organisers may require all competitors to wear personal floatation devices and/or wet or dry suits. **10.4** A tally system will be in use.
- **10.5** Mandatory Instructions on the Water Boards and Competitors in Difficulty. When the race committee considers that a board, its equipment or crew are not adequate for the existing or anticipated conditions, or that a board or crew member is in difficulty, it may instruct the board or crew not to launch, or to retire or to sail ashore or to accept outside help. The board and crew shall comply with such instructions without delay.
- **10.6** Pro fleet sailors and Wingfoil sailors must wear a helmet at all times. Amateur fleet sailors must wear a helmet when competing in light wind foiling.
- **10.7** Pro fleet sailors and Wingfoil sailors must wear an impact vest at all times. Amateur fleet sailors must wear an impact vest when competing in light wind foiling. An impact vest may also act as a personal flotation device in accordance with
- 10.8 All competitors shall carry at all times a SOLAS approved whistle.

### 11 ELECTRONIC COMMUNICATION

A board shall neither make nor receive radio or mobile telephone transmissions while racing.

## 12 SUPPORT & COACH BOATS / PERSONS

No coach boats or support boats will be permitted. Except that a Class Chair or the RYA may appoint coach and or support boats but only with the prior approval of the Head of Racing (<a href="mailto:racing@ukwindsurfing.com">racing@ukwindsurfing.com</a>). All applications must include completion of forms a) UKWA coaches code of conduct and b) UKWA coach & support boat registration form. Applications and forms must be submitted no later than the Monday prior to the said event.

#### 13 PRIZES

- **13.1** Prizes are awarded by the event sponsors at their discretion
- 13.2 Series prizes will be awarded by the UKWA at the last event / end of season prize giving.

# 14 RISK STATEMENT

RRS 4 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone."

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

- a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- b) They are responsible for the safety of themselves, their crew, their boat and their property whether afloat or ashore;
- c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- d) Their boat is in good order, equipped to sail in the event and they are fit to participate;
- **e)** The provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
- **f)** The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.
- G) It is their responsibility to familiarise themselves with any risk specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event, in person or virtually.

## 15 **INSURANCE**

Each participating board shall be insured with valid third-party liability insurance with a minimum cover of five million per event or the equivalent. This cover is automatically provided as part of UKWA membership excluding Wingfoil competitors. Wingfoil competitors must provide proof of third-party liability insurance with a minimum cover of five million per event or the equivalent at registration.

## 16 FURTHER INFORMATION

Further information relating to the event including news, directions to the event site, parking and camping, accommodation, and the social programme, will be published on the UKWA website prior to the event.
